Interpretation

In these Conditions, the following words and expressions shall have the followings meanings:

Agreement

means the general conditions, each contract and any document amending and/or expressed to be supplemental to any or all thereof will together constitute a single agreement between the client and AMAN-FX;

Client

A person who has account to managed and wants AMAN -FX to managed it.

Accounts

All accounts managed by AMAN -FX.

Fees

The commissions that deducted from the client account for each lot and refunded to the AMAN -FX.

Lot

is a unit measuring the transaction amount and is different for each product type of CFD: 1 lot = 100,000 of base currency;

Contract

Means a trade, purchase and sale of currencies or financial instruments in the market;

Contract Note

Means a document confirming an entry into a contract;

Business Day

A day on which banks and/ or foreign exchange markets are open for business.

Market Rules

the rules, regulations, customs and practices of any organization or market involved in the execution or settlement of a Contract and any exercise by any such organization or market of any power or authority conferred on it;

MANAGED FOREX ACCOUNTS POLICY AND CLARIFICATION OF DUTIES

1-For managed accounts, no churning is allowed. If the account manager is trading on the account/s only for the purpose of generating marketing incentives and commissions, restrictions on rebates and commissions may apply.

2-Revoking of these policies and/or the terms in the prime agreement terminates the managed account agreement immediately.

3-Client MUST agree jointly with the managed account regarding the commissions and fees.

4- All commissions and fees are declared and approved on the client trading agreement by the client himself.

5- The relation with the AMAN -FX is separate from the broker that clients chose it to open a forex account.

6- The commission and share profit fees will be calculated at the end of each month, a report will be sent by e-mail to the clients for all transaction traded within that month.

7- The clients may request review and/ or adjustments within one 5 business days.

8- The client must read the agreement and all above clarifications carefully. Make sure that you understand all terms and conditions including fees and commissions.

9- The clients funding his own account (_____) with the Broker (_____).

10- The client is obligated to deduct (_____ %) from the monthly profits for AMAN -FX and save (_____ %) from the monthly profits, and this percentage depend on the type of account (_____)which is mention in the website link .

11- AMAN -FX MUST NOT lose more than 30% from the main deposit (Initial deposit), and must stop trading if that happen.

Confidentiality




